Message from the Chairman

Dear Colleagues,

We continue to be successful as an organisation seeing increases both in our numbers of participants and our activities. Last year we had 342 participants from 54 countries. And for 2013 there are so far 355 laboratories registered from 58 countries with new countries including Iceland, Pakistan, Russia and the Sultanate of Oman. We are also expanding the schemes offered, see Pilot Schemes (page 2). We continue to collaborate with the SSIEM to provide training at the ETAC Academy (page 4).

Last year we made significant progress with improving and modernising the governance structures of the Foundation. We have redefined the inter relationships of the key committees and specified terms of reference for each. These are posted on the website under 'About us'. We are changing the composition of the Board of Governors to increase its independence from the operations management.

Performance Assessment

We are being encouraged by the European Society of Human Genetics to harmonise our scheme performance assessments with the other European genetic laboratory EQA providers. The principal points of difference lie with the allocation of points in the scoring systems and the adoption of the concept of 'critical errors'. Full details of the policies outlined here will be published later in the year.

Changes to DPT scoring

At a special meeting of the

Scientific Advisory Board in November we agreed that from 2013 the qualitative schemes will all adopt the same scoring system of two points for analytical results and two points for interpretation.

For the DPT scheme, there will no longer be an additional point for suggested further actions or testing. This will be included as part of the interpretation. This will also reduce the total score achievable to twenty four (with six samples) and acceptable performance

will generally be held to be a score above fourteen.

Critical Error

We are now considering the definition of 'critical error' and will inform all participants how this will affect the scoring. In principle this is a category of error that would be unacceptable to the majority of labs and would have a serious adverse effect on patient management. We are hoping to be able to institute this for 2014.

Appeals Policy

We are also introducing a better defined appeals system. This includes the facility for an ultimate appeal to the ESHG in cases of dispute. We realise how damaging it could be for a participant to be categorised as a poor performer. But ultimately the prime concern must be the best interests of the patients.

Educational Participants

One of the key aims of ERNDIM is education and to help laboratories provide better services. To help further this aim

we intend to define a new category of participation as 'educational'. This facility should be available for the participation registrations for 2014.

This category is intended for laboratories who are developing a test and need ERNDIM samples and feedback to facilitate, but who are not offering a clinical service at that time. An educational participation will mean that results are returned but not scored. No certificate of participation will be issued, but neither will poor performance be recorded.

DPT-CSCQ Results website

The system for entry of the DPT results by the website went live last year and is working well. It is now much easier for scheme advisors to evaluate performance when participants' replies are structured in a uniform way. If you have any queries or

Oligosaccharide Kit

Dr George Ruijter, Scientific Advisor to the Urine Mucopolysaccharide scheme, has collaborated with Dr Cas Weykamp of SKML, to produce a kit with urine samples representative of the classical oligosaccharidoses. The kits will be able to be purchased via the website later this year. The website will also have pdf images of the TLC patterns that should be obtained.

Progress to Accreditation

A key goal for ERNDIM is to become an accredited EQA provider. We intend to apply for accreditation through UKAS, the UK Accreditation Service. We are making steady progress and in the past year we have:

- Improved the governance of our committees
- · Appointed a Quality Manager
- Strengthened the

oversight function of the Board of Trustees

- Made the DPT schemes more uniform by coordinating them through CSCQ
- Begun to write job descriptions for our officers
- · Approved funding for a part time office assistant to support the ERNDIM Administrator.

Participant Survey 2012

We would like to thank everyone who responded to the Participant Survey in August 2012. The results from the annual survey help us to continue to improve the quality and efficiency of the ERNDIM schemes and also the service that we offer you. In 2012 we had a total of 137 responses and the overall for all score aspects of all schemes improved when compared to 2011.

The scores for all of the individual schemes improved (except for Cystine in WBC which stayed the same) with the scores for CDG and Quantitative Organic Acids showing the most improvement. The best scoring schemes were Special Assays Urine and Cystine in WBC while the worst scoring schemes were Lysosomal Enzymes and Acyl carnitines. Of the individual aspects

of the schemes the best score was for 'Frequency of samples' and the worst was for 'Value for Money', although this has improved since 2011. The most improved scores (compared to 2011) were for 'Billing Arrangements' and 'Frequency of Samples'.

EuroGentest 2 & the ESHG Genetic Services Quality Committee



Our activities fall within Unit 1 of EUGT2 which is headed by Ros Hastings of CEQA. The aims of our work package are:

- improved organisation and coordination of EQA schemes.
- when possible working towards harmonization with our partners in Molecular Genetics and Cytogenetics.
- accreditation of ERNDIM itself and our individual EQA schemes.
- developing generic criteria for assessing poor performance, especially when it is persistent.
- introducing measures to improve performance including the development of best

practice guidelines.

Activities this year have included a meeting of Unit 1 on 19th October 2012 in London and a ERNDIM SAB meeting in London on 28th of November 2012. At this meeting we discussed and agreed on how to assess performance in a harmonised way within all our proficiency type schemes including developing the concept of "critical error" (page 1).



ERNDIM continues to be represented in the ESHG Quality Committee, to whom we report on all of our activities, by Viktor Kožch and Brian Fowler.

We have met three times in 2012; Amsterdam (23rd March); Nuremburg (25th June); and London (23rd November).

As well as overseeing our EQA activities an important outcome of this committee is the plan to hold a Training Workshop - satellite meeting at the 2013 ESHG Paris conference. The main focus of this workshop will be to address common errors in all our schemes including ERNDIM ones and how these affect performance. ERNDIM participants are encouraged to attend.

Our participation in these activities continues to keep ERNDIM at the forefront of efforts to improve the quality of genetic testing in Europe.
