






ERNDIM: Participants





2011: Number of participants = 335


• Number of participating countries = 52

Pilot schemes

Pilot schemes running in 2016

- 1. Pterins in urine and Pterins/DHPR in dried blood spots, organised by Nenad Blau (University Children's Hospital, Zurich, Switzerland)
 - Pterins in urine will run as a full scheme for 2017 but the Pterins/DHPR in DBS will no longer operate

Pilot schemes planned for 2017

1. Cognitive Amino Acids, lead organiser is Prof Brian Fowler (Basel, Switzerland)

Other new schemes for 2017

Acylcarnitines in Serum: the acylcarnitines will be taken out of the Special Assays in serum scheme & will instead run as a separate scheme. This will allow the range of acylcarintines in the scheme to be expanded.



- ISO/IEC 17043 specifies the standards to be met for all aspects of a proficiency testing scheme and the management of the proficiency testing provider
- Initial GAP analysis allowed development of list of proposed actions required to meet ISO/IEC 17043
- Current estimate for meeting these requirements is late 2017
- Management requirements were prioritised but now working on the Technical Requirements

Progress so far:

- Implementation of formal document control using Q-Pulse software
- Formal management system implemented and reviewed annually
- Documentation of existing ERNDIM policies and procedures and agreement of new policies

- Participant's Guide summary of terms and conditions for EQA participation
- Formalisation of relationships with sub-contractors (SKML, CSCQ, Black Cat Websites)
- Changes to scheme calendar to allow annual reports & certificates to be published closer to the end
 of the scheme year
- Moving qualitative schemes to centralised sample dispatch and online results submission is in progress......

ERNDIM: Administration Office



- Staff: Sara Gardner (Executive Administrator, full time)
 Alice Brockway (Administration Assistant, 0.5 x full time)
- Responsible for EQA scheme administration & administration for annual SSIEM Academy
- Increasingly central to the day to day running of ERNDIM <u>but</u> reliant on one person (the Executive Administrator)
- In 2015 SSIEM agreed to:
 - Fund an additional Administration Assistant (0.5 x full time) to help with the administration of the SSIEM Academy.
 - Support one-off software development costs to allow all schemes to move to on-line results submission within an agreed timetable.
- In 2016, as recognition of the unique role ERNDIM has, SSIEM agreed to:
 - Fund a full time Scientific Administrator (deputy to Sara) for 3.5 years this will increase the resilience of the office, allow more time to be spent on preparing to apply for accreditation and will also allow ERNDIM time to develop a plan for sustainably funding this post for the future.



SSIEM Academy 2016

- 18th & 19st April 2016, Freiburg, Germany
- Accommodation (2 nights) paid by SSIEM
 & 75 Euro non-refundable
 registration fee with additional 12
 Euro fee for the Academy meal
- Course was heavily oversubscribed (66 applications for the clinical course and 57 for the laboratory course)
- Attended by 37 clinicians and 41 laboratory scientists from 30 countries
- The programme was a mix of joint and separate clinical/laboratory lectures & workshops
- Topics:
 - Amino Acids, Hyperammonemia,
 Urea cycle defects and Metabolic liver disease
