Accreditation of individual schemes – little progress

- Feasible, agreed as aim by SAB and Exec. Comm.
- Action plan to be prepared for next SAB (November 2)

### **Establishment of Performance Assessment**

### System based on Web site for Scientific Advisors

- Display of annual performance for each lab
- Each analyte scored
- Ranking within all labs
- Unsatisfactory performance for each analyte flagged
- total flags = overall performance

Tested in the SAB for 2006 - all samples in AA, OA, Special Assays, P&P, WC Cystine schemes

#### **ERNDIM – PATIENT SAMPLE ARCHIVIST**

One of the strengths of the qualitative ERNDIM schemes, such as the five regionally organised DPT schemes and the qualitative urinary organic scheme, is the opportunity for participants to encounter interesting and challenging samples. The best way of achieving this is to use **genuine patient**samples but as membership of these schemes continues to grow, supplies of suitable samples are becoming increasingly difficult to maintain.

#### **Proposal**

While most of us are well intentioned when new diagnoses are made, it is easy to overlook the need to arrange sample collection for EQA purposes. One solution may be to identify a **single co-ordinator** to pro-actively remind all participants about the value of patient samples for EQA. In addition, this co-ordinator would act as a well advertised single point of contact ensuring that it was easy and straightforward for people to submit samples to ERNDIM that they had obtained.

#### The person appointed

We are looking for a **well motivated** and enthusiastic **individual** to co-ordinate this activity, regularly advertise the need for samples by email by letter and at meetings, then receive, store and catalogue the samples sent. ERNDIM could contribute toward the cost of storage and reimburse transport costs for participants who agreed to submit samples.

This is an enormously important task, which will involve developing and maintaining contacts with laboratory staff, paediatricians and possibly patient groups throughout Europe. The person willing to undertake these tasks will have to ensure that all samples obtained are properly consented and that a record of this consent is stored.

The catalogue and sampled stored would be an extremely valuable resource for ERNDIM.
